GIFT CERTIFICATE CARDHOLDER AGREEMENT

USE OF THE GIFT CERTIFICATE

You may redeem your Gift Certificate for food and beverage charges including tips and taxes at the time of payment at Yella. Your Gift Certificate may be used up to, but not above, the available balance of your Gift Certificate. When your Gift Certificate is purchased, the available balance of your Gift Certificate will be active. This available balance will be reduced by each purchase and marked on your Gift Certificate by authorized Yella employees until your Gift Certificate balance reaches a zero balance. Your Gift Certificate will automatically be terminated when it has a zero balance. If your purchase amount exceeds the available balance of your Gift Certificate, you must combine the use of your Gift Certificate with another form of payment accepted by Yella.

USE LIMITATIONS

Gift Certificates are non-refundable and may not be redeemed for cash. This Gift Certificate will not be replaced if lost, stolen or destroyed. This Gift Certificate will expire seven years from date of purchase. Yella reserves the right to cancel a Gift Certificate if it believes that the Gift Certificate was obtained through fraudulent or unauthorized means. No duplicates or copies will be accepted.

LOST, STOLEN OR DESTROYED CERTIFICATES
